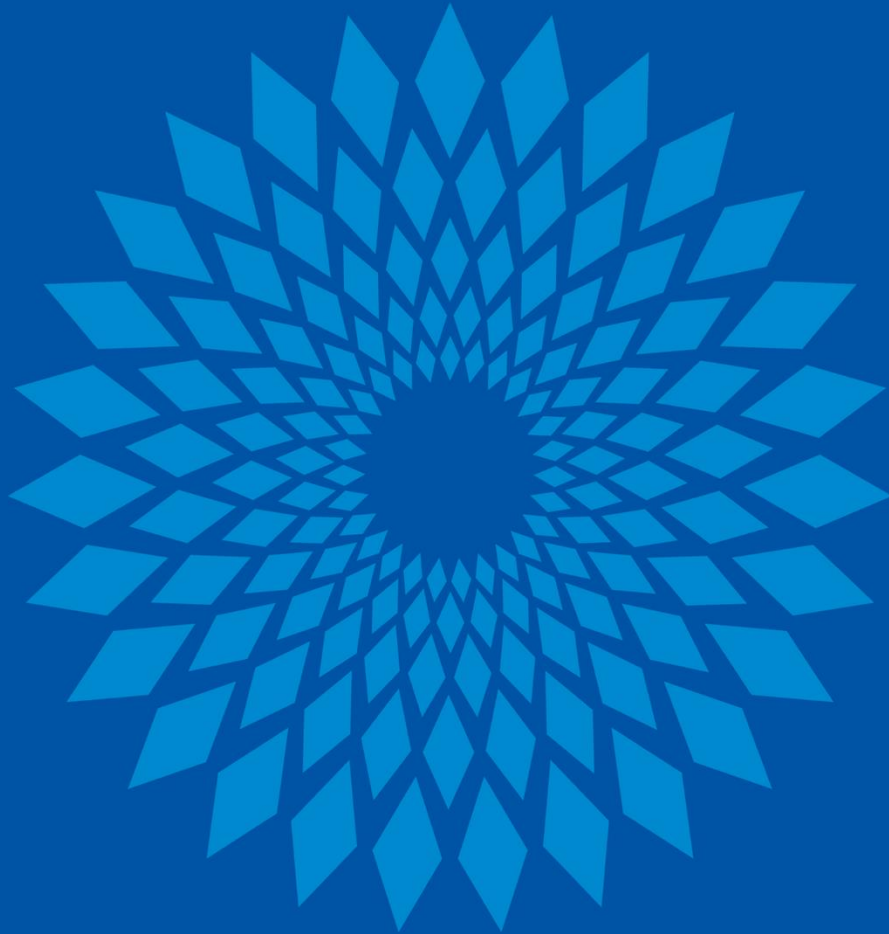

The events of recent years have shown us how important it is to have sufficient capacities in strategic areas such as medical supplies, chips or energy raw materials. In response to these challenges, the European Union has introduced new measures in the support of the digital ecosystem, be it policy strategies, legislative initiatives and financial instruments that aim to strengthen the European economy and prevent future problems. In this regard, how can we support cooperation with non-European countries and avoid protectionist tendencies in order to build a resilient European economy?

In this context, New European Innovation Agenda has been presented with the objective to position Europe as a leading player

on the global innovation scene. Will the proposed actions be sufficient to achieve such ambitious goals?

Panel 1:

### **Facing Challenges: Safe and Secure Artificial Intelligence**

To remain competitive in today's world, businesses must be able and willing to use smart digital solutions. One of the options how to make our work more efficient is to use artificial intelligence systems, which have been developing very dynamically in recent years and the number of their use cases has grown significantly. However, it is necessary to create an adequate environment to ensure the development of AI systems that are both safe and secure. What tools do we have at the moment to achieve these goals?

Panel 2:

### **EU as key player in the data economy**

Whether it's fast and accurate diagnosis of health problems using AI, autonomously parked cars, or energy grids using machine learning, all of the smart solutions require data on which algorithms can operate. Efficient and transparent data sharing will have a positive impact on the economy of the future. In this panel, we would like to focus on directions and means how to support the development of the data economy to make the EU a world leader in this area. We would like to discuss how we can support companies to operate in the data economy and how we can ensure effective digital governance/management in the data and digital economy.

Panel 3:

### **Cross-border data flows for the EU's digital future**

Digitization vastly transformed international trade. Businesses increasingly rely on automated and digitalized processes ranging from communication to customs procedures or service delivery itself. Transferring data became one of the key elements of competitiveness and innovation in the global digital economy. Nevertheless, disturbing efforts towards unjustified protection of data emerge, restricting or even totally banning the cross-



border flow of data. Several countries strive to facilitate trusted data transfers, although at different speeds. The panel aims to focus on how best to operationalize the abstract, yet essential data flows.

Panel 4:

**Safe Internet: Facing the Current Disinformation**

Disinformation has become a phenomenon that is an unwanted, but basically integral part of the internet world. How can we face it? National governments, the EU, non-governmental organisations, all come up with many actions and strategies in order to tackle these fraudulent and abusive practices. However, are these truly effective? And what role should the education system play?

## Transport from the Václav Havel Airport Prague

The Václav Havel Airport Prague is served by the public transportation. More information on travel to the Prague city centre is available at the Václav Havel Airport Prague [website](#).

**The easiest and fastest way to get to the Prague Congress Centre from here is to take the Airport Express Bus** to the Prague Main Railway Station, where you can transfer to the metro line C (red line) in direction “Háje”. The Prague Congress Centre is situated near the metro station “Vyšehrad”.

**Another way to get to the Prague city centre is to take the Bus No. 119.** The station is located in front of the Terminal 2 Arrivals building. The bus will bring you to the terminal station “Nádraží Veleslavín” to change for the metro line A (green line) in direction “Depo Hostivař”. To arrive at the metro station “Vyšehrad”, it is necessary to change at the metro station “Muzeum” for the metro line C (red line) in direction “Háje”.

## Public health measures

As of 9 April 2022, the protective measures regarding the conditions of entry into the Czech Republic in relation to the epidemic of Covid-19 have been suspended. Given that, **entry into the Czech Republic is no longer subject to any special epidemiological conditions to prevent the spread of the Covid-19 disease.** The entry ban for foreigners from third countries and the obligation to prove infection-free status have been lifted.

To ensure the safe conduct of the conference under CZ PRES, the **rules minimizing the Covid-19 spread disease will be set in a way to reduce the risks potentially jeopardizing the event.** Regular monitoring and assessment of the epidemiological situation will be provided. All participants should follow basic hygiene measures during the conference (i.e., hand and respiratory hygiene, etc.).

In accordance with the current Czech anti-epidemiological regulations, **respirators are voluntary in all areas.** In the case of worsening of the epidemiological situation, changes in preventive measures will be notified well in advance.
